

Terms and Conditions of Use for Diehl Aviation Media Center

By downloading photos, videos, data, graphics or other kinds of images (hereinafter jointly referred to as "Images") from the Diehl Aviation Media Center, you (hereinafter referred to as "the User") accept the following Terms and Conditions of Use:

1. Copyright

All rights to the Images provided in the Diehl Aviation Media Center remain exclusively with Diehl Aerospace GmbH (hereinafter referred to as "Diehl Aviation"). The User acknowledges that Diehl Aviation retains all rights, title, and interest in and to the Images, including all copyrights. Any use of the Images in accordance with these Terms and conditions of use shall include the following attribution: "©Diehl Aviation – All rights reserved."

2. Right of use

Diehl Aviation grants the User a non-exclusive, time-limited, revocable, right of use to the Images free of charge exclusively for editorial use by journalists and editors. The User shall use the Images solely for news reporting and editorial purposes. Any other use is strictly prohibited.

3. No Amendments or Modifications

The User shall not amend, modify, or alter the Images in any way. The Images shall not be used for artificial intelligence (AI) purposes or any other automated processes.

4. No Commercial Use

The User shall not use the Images for any commercial purposes without the prior written consent of Diehl Aviation. The Images shall not be used in advertisements, marketing materials, or any other commercial endeavors of the User.

5. Right to Deny Use

Diehl Aviation reserves the right to deny the use of the Images at its sole discretion. If Diehl Aviation determines that the use of the Images is inappropriate or in violation of these Terms and conditions of use, Diehl Aviation may revoke the User's right to use the Images. If Diehl Aviation revokes the User's right to use the

Images, Diehl Aviation is entitled to request deletion of the Images and all materials resulting of the use of the Images.

6. Liability
